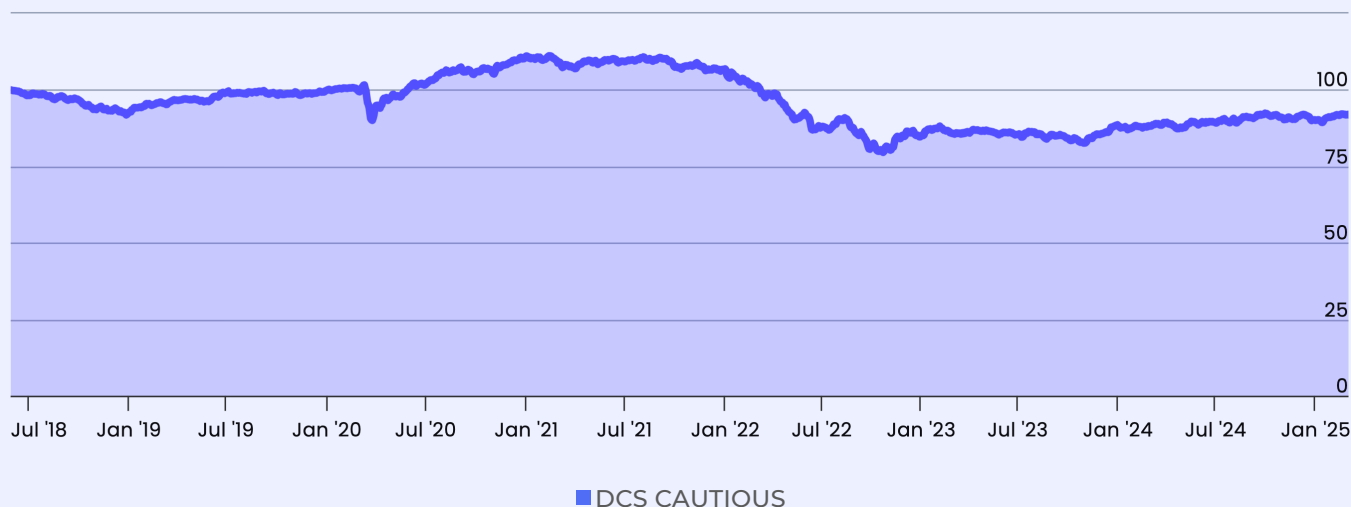


Objetivo del fondo

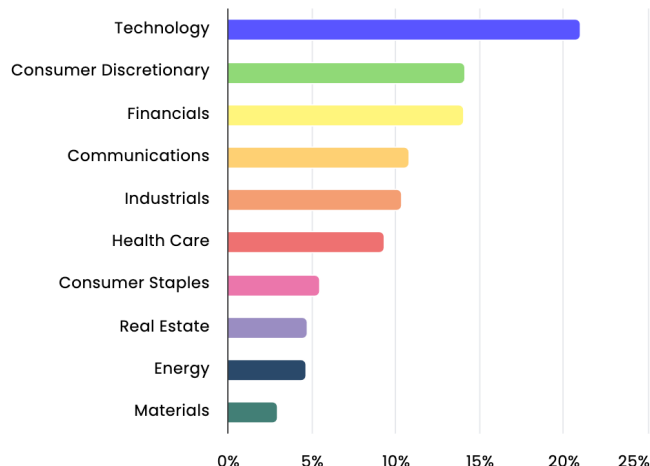
