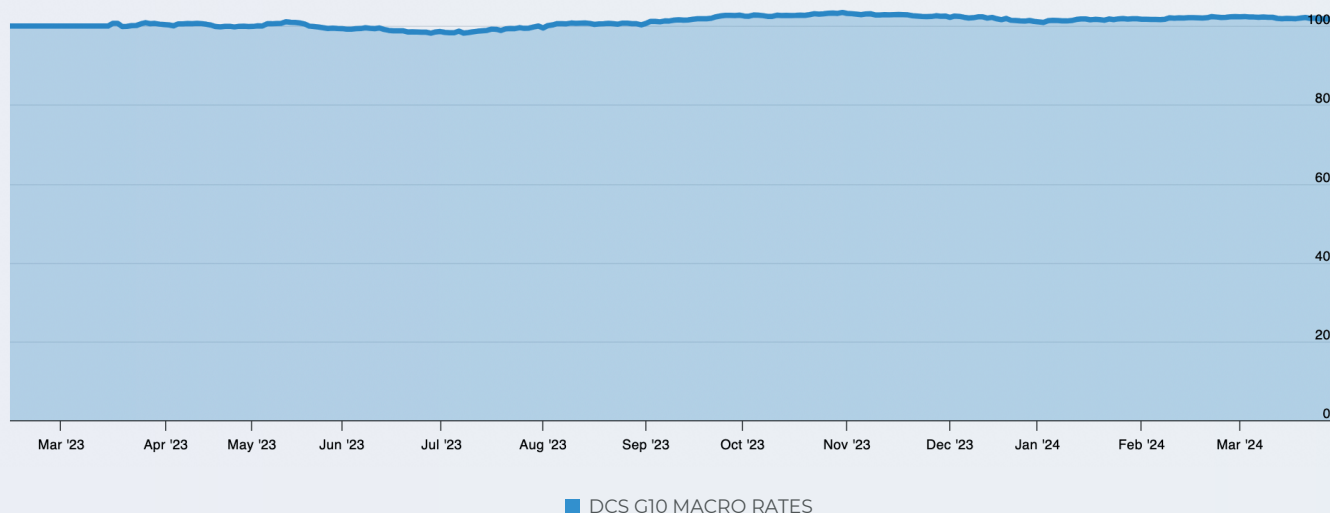


Fund objective

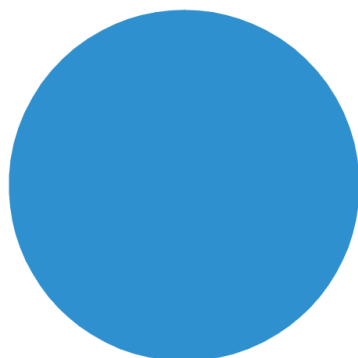

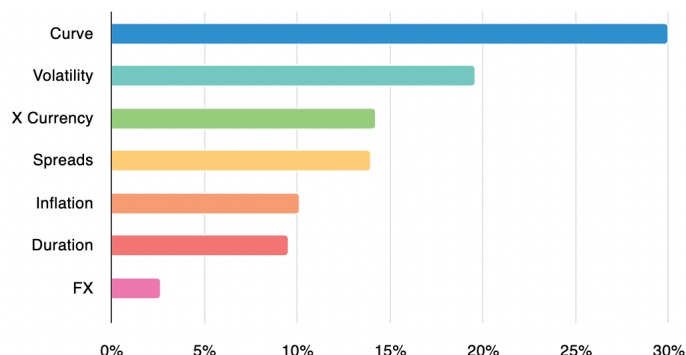

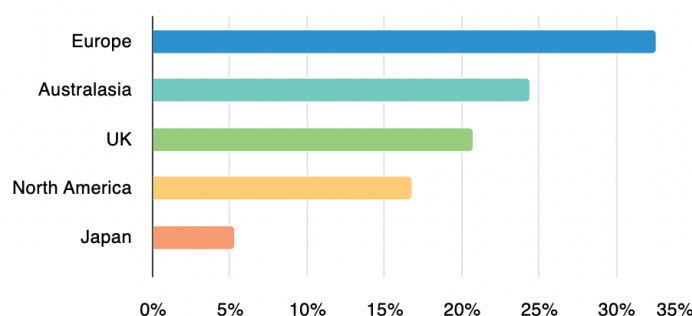
