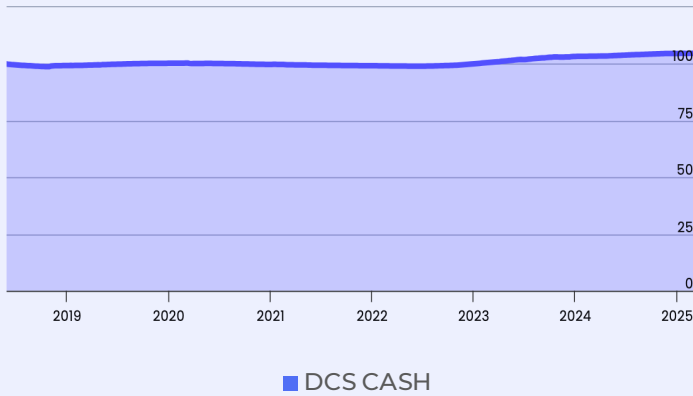


## Fund objective

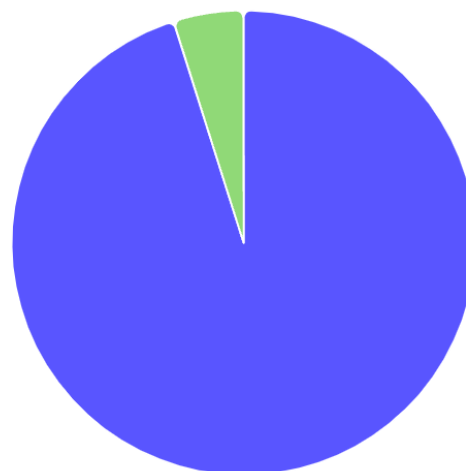
