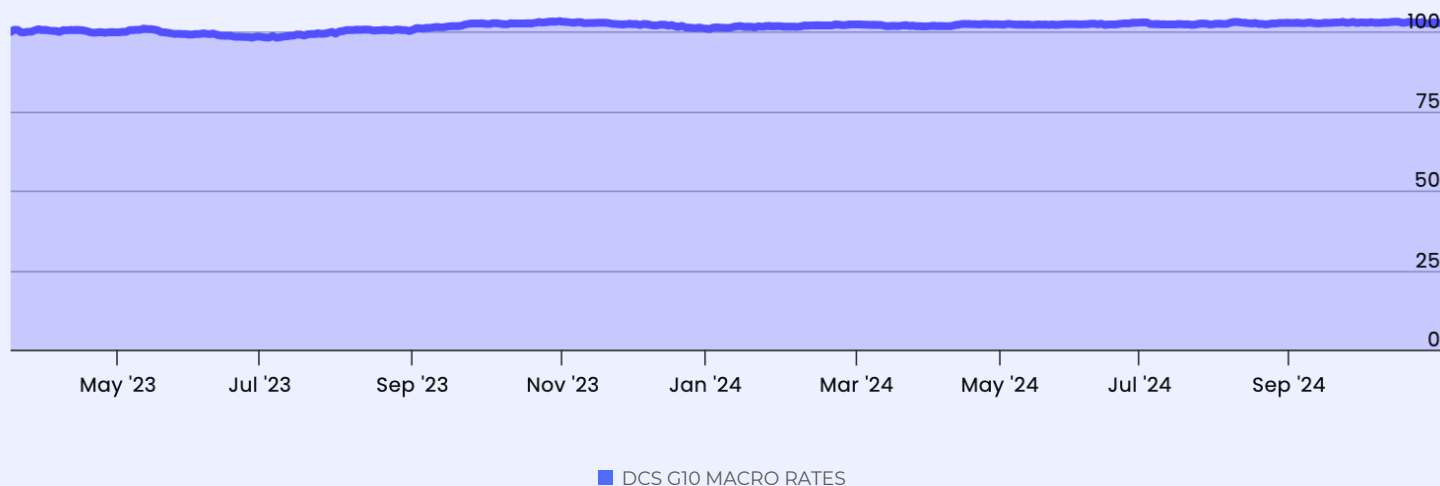




## Fund objective

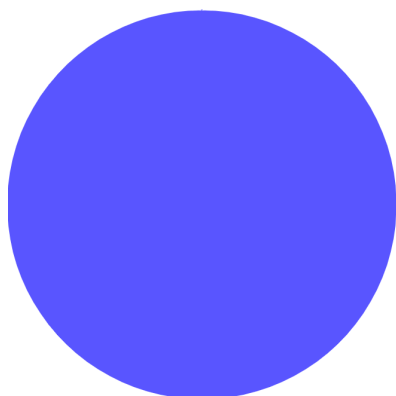

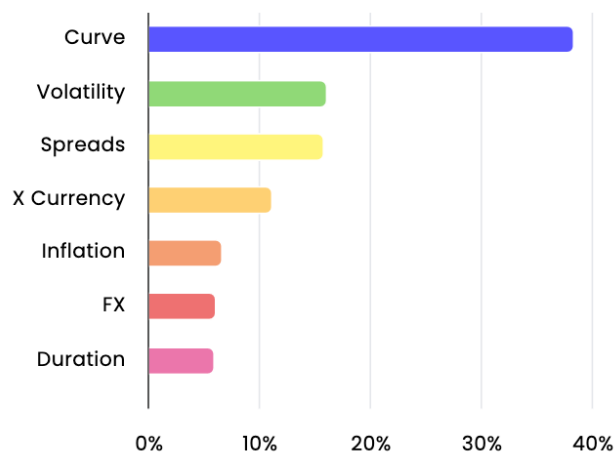

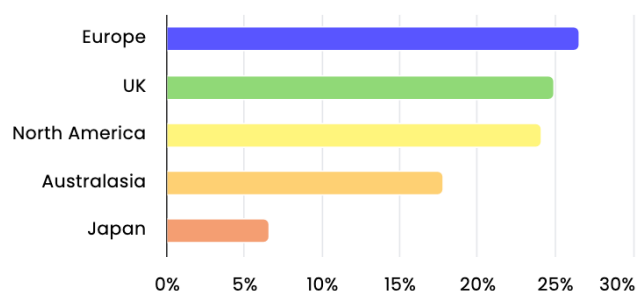
